In line with our legal obligation under Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (Official Journal of the European Union of 4th May 2016, L 119/1), further "GDPR", the Podlasie Opera and Philharmonic—European Art Centre in Białystok hereby informs that:

1. the controller of your personal data is the Podlasie Opera and Philharmonic—European Art Centre in Białystok, ul. Odeska 1, 15-406 Białystok;
2. your data is managed by the Personal Data Protection Supervisor (IOD), e-mail: iod@oifp.eu;
3. your personal data is processed pursuant to Article 6(1b), (1c) and (1f) GDPR, i.e. such processing is necessary for the purposes of the legitimate interests pursued by the controller, in particular for marketing purposes concerning the controller's products and services and for the purpose of executing agreements, examining complaints as well as determining, pursuing and defending counterclaims;
4. your data may also be received by providers of IT and legal services working with the Podlasie Opera and Philharmonic—European Art Centre in Białystok, based on strictly defined rules;
5. your personal data shall not be transferred to third countries or international organizations;
6. your personal data shall only be processed in the scope required for the purposes of such processing, in particular for the duration of marketing actions concerning the controller's products and services and for the duration of agreements you have signed with the Podlasie Opera and Philharmonic—European Art Centre in Białystok, including the period required to exercise claims arising out of such agreements;
7. you may request access to your personal data and have the right to rectify or erase such data, or transmit such data to another controller as well as to limit or object to the processing of such data;
8. you have the right to lodge a complaint with the President of the Personal Data Protection Office (PUODO);
9. the processing of your personal data is necessary for the purposes of the legitimate interests pursued by the controller;
10. your personal data shall not be subject to automated decision-making processes by the controller, including profiling, in the process of pursuing the aforementioned purposes.
